Notice of Meeting

Our Notice of Meeting will be released online on Friday, 25 September and emailed to investors who have registered their email details with the share registry. We will not be sending you a hard copy of the Notice of Meeting by mail ahead of our AGM. This approach is consistent with the relief provided by the Commonwealth Treasurer in response to the COVID-19 pandemic.

We will be sending Shareholders a hardcopy Voting Form by mail. Shareholders will receive this toward the end of September 2020. You can also download a copy from our AGM website from 25 September 2020.
